

Sung Woo Kahng, Ph.D., BCBA-D is an Associate Professor in the Department of Health Psychology at the University of Missouri and the Director of the Applied Behavioral Intervention Service of the MU Thompson Center for Autism and Neurodevelopmental Disorders. Prior to his current position, he was a faculty member in the Department of Behavioral Psychology and a senior behavior analyst on the Neurobehavioral Unit at the Kennedy Krieger Institute as well as an associate professor in the Department of Psychiatry and Behavioral Sciences at the Johns Hopkins University School of Medicine. Dr.

Kahng graduated from Kalamazoo College with a bachelor's of arts in psychology and received his Ph.D. in behavior analysis from the University of Florida. He was recently appointed an Associate Editor for the *Journal of Applied Behavior Analysis* where he also served on the Board of Editors. Additionally, he is on the Board of Editors for *Behavioral Intervention* and has served as an *ad hoc* reviewer for numerous other journals. He is a Board Certified Behavior Analyst and a Licensed Behavior Analyst in the State of Missouri. Dr. Kahng is the recipient of the 2003 B.F. Skinner New Researcher Award given by Division 25 of the American Psychological Association. He has been invited to present at regional, national and international events, as well as to consult for numerous organizations. Dr. Kahng has co-authored over 70 peer reviewed articles and chapters. The focus of his research and clinical work has been on assessing and treating behaviors exhibited by individuals with developmental disabilities. He is also interested in a broader research agenda, which includes topics related to obesity and aging. Finally, he has mentored numerous undergraduate, master's level, and predoctoral students as well as post-doctoral fellows.

Dr. Kahng will be conducting a workshop on Thursday morning. He will be covering, "The Functional Analysis of Problem Behavior: Practice and Research." Dr. Kahng also will be one of our keynote speakers on Friday, presenting, "A Simplified Outcome Measure for Use During Treatment Evaluations." We are very excited to have Dr. Kahng present at our 10th annual conference.

10th Annual Conference Invited Presenters

Alice Shillingsburg, Ph.D., BCBA-D in clinical psychology at Auburn University. She is currently an assistant professor in the division of Autism and Related Disorders in the Department of Pediatrics at Emory University and the Program Director of the Language and Learning Clinic at the Marcus Autism Center. Dr. Shillingsburg is a licensed psychologist and Board Certified Behavior Analyst at the Doctoral level. Her clinical expertise includes developing language and behavioral programming to address a variety of behavioral difficulties and communication deficits associated with developmental disabilities and autism spectrum disorders (ASD). Dr. Shillingsburg is associate editor and editorial board member of *The Analysis of Verbal Behavior* and former editorial board member of *Journal of Applied Behavior Analysis*. Her current research interests include theoretical and practical applications of verbal behavior and the assessment and treatment of language deficits particularly strategies to promote language acquisition and social interaction skills in children with autism.



Dr. Schillingsburg will be conducting a workshop on Thursday afternoon. She will be addressing, "Improving Social Initiation, Engagement, Communication, and Play in Children with Autism". Dr. Schillingsburg also will be serving as a keynote speaker during Friday's lineup, presenting, "Strategies to Assess and Promote Emergence of Verbal Behavior in Children with Autism". We are very excited to have Dr. Schillingsburg join us for our 10th annual conference!



Cathleen Piazza, Ph.D., BCBA-D is a Professor of Pediatrics and Director of the Pediatric Feeding Disorders Program at the University of Nebraska Medical Center in Omaha, Nebraska. She previously directed similar programs at the Marcus Institute in Atlanta and at the Johns Hopkins University School of Medicine in Baltimore. Dr. Piazza and her colleagues have examined various aspects of feeding behavior and have developed a series of interventions to address one of the most common health problems in children. Her research in this area has been among the most systematic in the field and has firmly established behavioral approaches as preferred methods for assessment and treatment. In her roles as clinical, research, and training director, Dr. Piazza has mentored a large number of interns and fellows who have gone on to make significant contributions to the field. Highly regarded for

her general expertise in research methodology, Dr. Piazza is a former Editor of the *Journal of Applied Behavior Analysis*.

Dr. Piazza will be presenting on Friday morning, "A Comparison of a Modified Sequential Oral Sensory Approach to an Applied Behavior-Analytic Approach in the Treatment of Food Selectivity in Children with Autism Spectrum Disorders." We are very excited to have Dr. Piazza share her unique expertise on the assessment and treatment of pediatric feeding disorders!

Regina Carroll, Ph.D., BCBA-D is an Assistant Professor of Psychology at West Virginia University. She received a Master's in Behavior Analysis from Saint Cloud State University under the supervision of Dr. John Rapp, and her Ph.D. in Behavior Analysis from the University of Nebraska Medical Center's Munroe-Meyer Institute under the supervision of Drs. Tiffany Kodak and Wayne Fisher. Dr. Carroll is an editorial board member for the *Journal of Applied Behavior Analysis* and has served as a guest reviewer for seven other behavior analytic journals. She also serves on the board of directors for the Southeastern Association for Behavior Analysis and the West Virginia Behavior Analysis Association. Dr. Carroll's research interests include evaluating instructional interventions for individuals with an autism spectrum disorder and related intellectual disabilities, verbal behavior, and treatment integrity.



Dr. Carroll will be presenting on Friday afternoon, "Procedural Variables Influencing Student Learning Outcomes During One-on-One Teaching." We are very excited to have Dr. Carroll share her unique expertise with us and will be releasing more details about her presentation on our website very soon!

Nicole DeRosa, Psy.D., BCBA-D received her Psy.D. in 2012 from the University of Southern Maine in School Psychology with an emphasis in Applied Behavior Analysis. She completed a pre-doctoral internship in behavioral psychology at the University of Nebraska Medical Center, Munroe-Meyer Institute's Center for Autism Spectrum Disorders. In 2012, she was recruited for a post-doctoral position at the Family Behavior Analysis Program, Department of Pediatrics, Upstate Medical University, where she is currently employed as Director of the Severe Behavior Disorders Sub-Clinic. Dr. DeRosa also has experience implement-

ing behavioral treatments in an integrated day treatment and school program with children and adolescents diagnosed with emotional and behavioral disorders. In addition to her experience relating to severe behavior disorders, Dr. DeRosa has experience implementing and supervising the implementation of early-intensive behavioral intervention services for individuals with developmental disabilities, including autism spectrum doisorder. Dr. DeRosa has published several peerreviewed papers, co-authored a book chapter, and delivered numerous professional presentations at both local and national conferences in the areas of applied behavior analysis and childhood behavior disorders. Her current research interests include severe behavior disorders, functional communication training, behavioral economics, pediatric feeding disorders, and parent/caregiver training.

PROPOSED BYLAW CHANGES

Two changes to the HLABA's Bylaws have been proposed. These will be voted upon during the business meeting at the HLABA conference. The exact wording will be sent to HLABA members a few weeks ahead of the conference. Here is a summary of the changes.

- 1.) The position of secretary-treasurer is being split so there will be a Secretary position and a Treasurer position. The Secretary is responsible for keeping the organization's minutes and accurate membership records. The treasurer is responsible for all financial aspects of the organization. With this change, one Representative-at-Large position will be eliminated.
- 2.) We are adding a clause to the Bylaws that clarifies how a position is filled when a Board member has vacated that position and allows for the removal of Board Members who fails to regularly attend Board meetings.

Vice President:

Presentation Formats

<u>Posters</u> consist of visual displays of information describing and reporting the results of empirical research. The poster session will be held on March 3rd from 5:00 pm to 7:00 pm at the Double Tree Hotel. We will provide easels to display posters. **Students submitting a poster will be included in a Poster Contest!** The HLABA Board members and invited judges will score the posters on their research idea and contribution to the field of Behavior Analysis. The winner will receive \$200 to encourage attendance at ABAI!

<u>Paper Addresses</u> are individual oral presentations describing ABA-related conceptual, historical, or methodological issues or empirical research. Paper addresses should be no more than 20 minutes in length and may be combined with other Papers in longer sessions. The program committee reserves the right to group individual Paper Addresses with other Paper Addresses or to assign a Paper Address submission to a Poster based on scheduling constraints.

Symposia are a series of 15 to 20-minute presentations organized around an ABA-related theme or issue. A chairperson will organize the presentations and moderate the session, assuring timeframes are maintained and that the session ends on time. A discussant will deliver remarks at the end, which are intended to highlight and integrate the contributions of the various speakers. Symposia are 75 minutes in length. HLABA is not responsible for designating or notifying a chairperson or discussant.

<u>Panel Discussions</u> consist of several speakers' responses to a question or issue with time allotted for audience participation. A panel discussion is organized and led by a chairperson who is responsible for the flow of the session. Panel discussions are 75 minutes in length. HLABA is not responsible for designating or notifying a chairperson.

Exhibits are an opportunity for ABA-related training programs, commercial vendors, agencies, and businesses to display information about their program or promote products for sale. Display space includes one 3' x 8' skirted table. The fee for an exhibit is \$75 or \$25 for HLABA members renewing membership from the previous year. We will display exhibits in the lunch area, so that attendees may visit the exhibits before and after lunch.

Submission Instructions:

All proposals should be typed in MSWord and submitted as an email attachment to the Conference Coordinator (on the next page). Contact the Conference Coordinator if other arrangements are necessary. We will not accept incomplete submissions. Please follow submission outline instructions for each submitted presentation. Although there is no limit on the number of presentations in which an author may participate, the overall number of submissions may be limited depending on scheduling constraints.

Submission Outline:

Please Specify One Type of Presentation: Poster, Paper address, Symposium, Panel Discussion, Display, Exhibit

Title: Symposia will include a session title and individual titles for each presentation.

Chairperson: Include the name and (one) affiliation for all symposia and panel discussions.

Discussant: Include the name and (one) affiliation for symposia only.

Contact Information: Include name, email address, and phone number for the presenting author. All correspondence will be sent to this email address.

Abstract/Display/Exhibit Description:

- 1) **Abstracts** are required for posters, paper addresses, symposia, and panel discussions. Abstracts are required for each presenter in a symposium. The abstract must follow APA style and be no more than 200 words. Keep in mind, the content of your abstract will govern the attendance of your session and interest in your poster.
- 2) **Display/Exhibit Descriptions** are required for displays. Descriptions should include information about the display, which will be published in the program. The description should be no more than 200 words.

Author Information: For posters, paper addresses, symposia, and panel discussions, include the presenting author's name and (one) affiliation. The presenting author should be listed in ALL UPPERCASE LETTERS. If not designated, we will assign the first author as the presenting author. The presenting author must be present at the event and registered to attend the conference

Schedule Preference will be honored when possible.

Conference Submissions: We will send the contact author a confirmation of acceptance by February 12th, 2016. If accepted, the confirmation will include the date and time of the presentation. The contact author is responsible for contacting all other presenters to inform them of the presentation's acceptance and the date and time of the presentation.

Equipment

HLABA will provide a screen. The size of the screen will depend on the room size. We will also provide a microphone for larger rooms. HLABA will provide a projector and a PC computer. Presenters are responsible for all other equipment unless other arrangements are made with HLABA in advance.

Continuing Education by BACB

To have your paper address, symposium, or panel discussion considered for BACB CEUs, include a curriculum vita (CV) and a brief description of the objectives for your presentation with your submission (include a copy of the CV and the objectives for each individual presentation for symposia). Objectives should be written in behavioral terms that specify what the participants will do during the event or should be able to do after completing the event, rather than what the participants will "know" or what the instructor (s) will do. See the BACB website (www.bacb.com) for further information on BACB requirements. The CV and objectives will be reviewed by the HLABA CE Coordinator to assure it meets BACB requirements. We will send acceptance emails when the event is officially approved. One BACB CE may be granted for each 50 minutes of approved instruction or presentation (or 0.5 CE for 25 minutes).
